

Hospital Association COVID-19 Preparedness and Response Activities

April 2020 - Cooperative Agreement

Assistant Secretary for Preparedness and Response (ASPR)

On April 13, 2020, SCHA was awarded \$696,184 by ASPR "to support the urgent preparedness and response needs of hospitals, health systems, and health care workers on the front lines of this pandemic." These funds should primarily be used by hospitals to purchase "[personal protective equipment] in accordance with CDC guidelines." Hospitals may also use their grant allocations to "plan and implement expanded telemedicine, telehealth, or other virtual health capabilities to ensure that appropriate care can be provided to individuals in their homes or residential facilities."

Each entity licensed as a hospital by DHEC will receive a base allocation of \$2,500; this includes all facilities licensed under Regulation 61-16 except for those identified by DHEC as an "infirmiry." In addition to this base allocation, licensees that DHEC has not categorized as a "specialty hospital" will share the remaining funds proportionately, based upon their licensed beds.
