The Joint Commission

Dr. Campbell is the Clinical Director of the Standards Interpretation Group (SIG) at TJC. In this role, he is responsible for providing interpretation of TJC standards in all accreditation programs and provides direction and leadership to surveyors and SIG staff. He also participates as a consultant in the development and revision of standards and supports ongoing accreditation services and special projects. Dr. Campbell also serves as the Director of Medication Management for TJC Enterprise where he serves as the subject matter expert for all medication management related topics, including standards. Further, he functions as a TJC Surveyor and Reviewer in the Medication Compounding Certification Program. Dr. Campbell has an extensive background as a healthcare pharmacist and leader. He is a licensed Registered Pharmacist in FL and holds a Six Sigma Green Belt.

Ms. Lisa Hardesty is an experienced health care consultant with numerous years of experience in environment of care and life safety. Ms. Hardesty worked as the Environment of Care and Sustainability Manager at a Malcolm Baldrige National Quality Award winning hospital.
