Bridging the PDC & Accreditation Gap

At the conclusion of this session the participants will be able to:

1. Agree that the facility leadership team has the responsibility to identify accreditation gaps and inform the C-Suite about the Risk of Inaction. Securing project funds for Accreditation Assurance and commissioning. What are the necessary steps and how do we implement this process into our PDC process?
2. Provide and review a specific task list that can be used to assess the maturity of each Health System and determine where in the 6-step process to engage. For example, some health systems have healthy PDC systems and processes, others do not. Regardless, being “Ready Day One” for accreditation is the building block of the operational excellence, so everyone needs to address their true capability and correct if necessary.
3. Provide real-world examples of how a comprehensive Accreditation Assurance program can improve operational excellence and mitigate risk for the facility. The creation of facility friendly, survey ready life safety drawings, life safety systems

assessments and documentation review is crucial to all facility operations and accreditation.

4. Provide a toolbox with a detailed list of items to consider to create and implement an Accreditation Assurance program to improve operational excellence, mitigate risk for the facility, and be Ready Day One.
